Land and Water Conservation Fund (LWCF)

LWCF Act of 1965

- Administered by the U.S. Department of Interior National Park Service
- A Federal, State and Local Partnership with a **State Assistance Program**
- Provides a 50% matching-fund reimbursement towards acquisition and/or development projects for public outdoor recreation areas and facilities
- Property is protected in perpetuity with guaranteed public outdoor recreation access – forever providing a meaningful resource for your community and future generations





Who Can Apply?

Eligible Applicants

- Localities
 - Town, City, County, etc.
- State Agencies
 - DWR, DOF, or DCR, etc.
- Tribes
 - Federal and/or State recognized
- Regional Recreation Authorities
 - Legally recorded by General Assembly

Ineligible

Non-profits, charitable organizations, businesses, and individuals are **NOT** eligible

The 'applicant' must ultimately be able to hold and protect the property forever with no change in ownership required or chance of dissolution of organization.

The **applicant** also must have ability to **fully fund** the project while waiting for the reimbursed 50% amount.

The applicant must have staff available to administer the grant through closeout.



Project Type: Acquisition

<u>Eligible</u>

- Lands, wetlands, waters for public outdoor recreation
- Add parcels to:
 - Developed park areas
 - Undeveloped areas for passive recreation

<u>Ineligible</u>

 Land that is not currently available to the public – parks already owned by the applicant not eligible

The ENTIRE park property boundary will be protected

- Must be a 'Fee Simple' acquisition to ensure full ownership rights and public access with ability to ensure provisions of LWCF Act
- Can be accomplished through purchase, transfer, or donation (depends on scope of project)
- Value is based on UASFLA appraisal
 - Appraisal is completed within 1 year of project submission
 - Independently reviewed
 - Costs of appraisal, legal fees, due diligence, surveys NOT eligible for match reimbursement

Acquisition – Recreation Opportunities

- Must have a plan for how the land will be available for public recreation within 3 years
- Existing structures need to support outdoor recreation uses
 - Future structures must support public outdoor recreation
 - Maintenance and equipment storage buildings may support outdoor recreation

Project Type: Development

Properties already owned/protected by the applicant

ENTIRE park property will be included in the "LWCF Boundary"

- Consider future uses or needs of other park areas, and individual parcels included in the LWCF boundary. Needs to be compatible with LWCF, and cannot be sold or converted to non-public recreation uses.
- Fund development that provides:
- Public access to park areas and meaningful experiences
- Accessible amenities and resilient infrastructure
- Safe experiences and promotes healthy communities
- Protects the community investment of the shared area

Project type examples (review NPS manual for criteria):

- Renovating Facilities
- Accessible Facilities

Project Type: Development

Tip: Provide a clear project scope with a realistic budget

- Describe what you *can accomplish* within 3 years
 - Scope can be one recreation component, a larger park plan, or can be the same type of recreation amenity at multiple park sites
- Ensure the budget is up-to-date and aligns with current costs
 - Important for scoring and also carefully reviewed by NPS
 - Pre-planning expenses (up to 3 years from award date) as match
- LWCF requires 'Build America, Buy America' compliance
 - Construction products must have certification documentation
- Follow procurement requirements
- Construction must begin within 1 year of project award
 - Reasonable timeline including permitting requirements, purchase of products
- Ask yourself is my park plan 'ready enough'?
 - Local community and governmental support
 - Very clear plan of what to accomplish where, how, when
 - Able to complete the State and Federal environmental/historical reviews*



Project Type: Renovation/Redevelopment

Many older parks are ready to bring facilities to newer standards that better serve community needs

- Bring facility(s) and/or amenities up to accessibility and resilient standards
- Obsolescence Deteriorated, and usefulness is impaired or needs to be upgraded to meet public health, safety, and recreation needs
 - Adaptation of new or existing outdoor facilities for barrier-free experiences (see VOP Section 2.2)
 - Change recreation use (pool to splashpad; resurfacing trails; replacing lighting; court to pickleball)
- Meets recommendations within the Virginia Outdoors Plan 2024 (Section 2.1.4)

Generally, funding is allowed for rehabilitation unless due to willful neglect and inadequate maintenance – clearly indicate the need and reason.



Project Type: Renovation/Redevelopment

Many parks need to adapt facilities to meet the local ecological or environmental factors

Protection of the recreation and natural values of the area

- Floodplain resiliency relocation of facilities or design of resilient infrastructure
- Invasive species removal, landscape restoration, native planting
- Natural shoreline or riverbank stabilization for resiliency and ecological restoration
 - Must be part of onsite recreation development greater than or equal the cost of the stabilization work
 - Beach nourishment is *ineligible*
- Meets recommendations within the Virginia Outdoors Plan 2024 (See Section 3)



Project Type: Combination

Acquisition plus Development and/or Renovation

Examples

- A Fee Simple property is paired with development of park amenities
 - In certain instances, the appraised value of the donated property may be used as match
- Acquisition of property from a private owner that already has structures that can be renovated for recreation support uses
- One governmental entity transferring property to an eligible applicant that will perform on-site amenity improvements

Ineligible Project Types/Costs

Review the NPS manual and DCR LWCF website

- Indoor Facilities recreation centers, dining, lodges, hotels, etc.
- Facilities for professional sports
- Acquisitions of **historic** sites and structures
- **Regular** operation and maintenance
- Condemnation of any kind
- Indirect costs/Incidental costs
- Equipment **purchases**
- Interest expenses, taxes, contingency reserves







A Message About Conversions

"Any property so acquired and/or developed may not be wholly or partly converted to other than public outdoor recreation use without approval of NPS pursuant to the LWCF Act ((54 U.S.C. § 200305(f)(3)) and conversion requirements outlined in regulations (36 C.F.R. § 59.3)." – NPS LWCF Manual

The project sponsor is responsible for maintaining the LWCF Boundary and public use of the entire park. If a conversion were proposed:

Multiple year process that **should be avoided** – you are the first line of protecting these parks.

- **Immediately** consult DCR with a map of proposed impact area and full description of potential impact. DCR consults with NPS
- Must determine a **replacement land** of equal or greater economic value as well as reasonable recreation usefulness and location
- All properties would require appraisals, appraisal reviews, full NEPA and NHPA, multiple levels of reviews, and final approval by the U.S. Department of Interior (DOI) Secretary

Funding Information

Minimum grant award request is **\$125,000** (for a total project cost of \$250,000)

Maximum grant award request is **\$2 million**

LWCF is a Match Reimbursement Federal grant program

Funds are reimbursed 50% after project completion and fulfillment of the project grant award agreement (e.g. project scope accomplished, proof of payment)

Cost principles of 2 C.F.R. Part 200 will be followed in determining the allowability and allocability of costs.



Grant Round Timeline

- Aug 28 Sep 30: Committee Scoring
- Early Oct –selected applicants contacted to move forward, site inspections
- Oct 31 all compliance documents due
- Nov 2025 Jan 2026: DCR NPS coordination for project review
- Jan Mar 2026 awarding process
- April 2026 expected start date (Acquisition, Development, Combination projects)



Gateway/Progress Forward

- DCR Staff and LWCF Committee determines if project meets LWCF program requirements
- DCR contacts applicant, conducts an on-site inspection, discuss project details
- All Real Estate deed research and ownership verification is completed
- All required NEPA/Section 106 must be completed
 - Agency correspondence satisfied; surveys completed if required
 - Official letterhead PDF's
 - DCR & NPS will review to complete a final determination
- Project is DCR-approved for Federal 'grant portal' submission
- Project is reviewed by NPS and, if approved, is awarded (Notice of Award)
- Project Sponsor (applicant) receives sub-award agreement
- Grant Agreement is signed by Project Sponsor and DCR
- Project can begin!





What to be aware of up front:

- Is there clear ownership?
 - Deed research, clear title, and boundary confirmation
 - Verified seller and plan for required timeframe
- Surveys may be needed
 - Possible requests for Historical, Cultural, and/or Archeological Surveys from DHR or Tribal Consult
 - Field studies for rare, threatened, or endangered species
 - Floodplain analysis and/or wetland delineation
- Projects with multiple and/or complex components may require more extensive design and engineering work than more basic park plans.
 - Where are you in that timeline? If it has not begun it may not make it through the process in time.
- Please determine if your **timelines** and **available funds** are sufficient.
- DCR staff can help guide through the processes but cannot do the coordination
- Do not begin project acquisition or construction until all outstanding compliance issues are satisfied

DCR Application & Documents

The DCR Application follows the DCR LWCF 2025 Application Manual

- **Checklist**: Refer to Appendix A & *Environmental Review Guidance Document*
 - Pre-screening NEPA and Section 106 documentation. Initial agency contact.
 - Save each item as a PDF. Use same naming (i.e. "Park Name-USFWS iPAC Report")
 Checklist: Additional Items, if selected: final agency letters for NPS review
- Section A: direct contact dedicated to project administration
- Section B: Project Details = Q 12 <u>Accessibility</u> & 13 reference <u>VOP Featured</u> <u>Projects Dashboard</u>
- Section C: Important information to confirm property details and ensure acreage is consistent; LWCF sites can be viewed on <u>VOP Mapper</u>
- Section D: Coincides with Scoring Criteria give the committee enough information to fully understand the project application but succinct;
 - Source the VOP material, survey results, and/or dashboards as appropriate

It is a unique format... do the best you can.

- Unnecessary items have been noted 'leave blank' ۲
- Leave all content only fill out applicable sections
- □ New project grant application (fill out section 1.0, 2.0 with relevant sub-section(s), and 3.0): \Box Acquisition (fill out section 2.1)
 - Development/Renovation (fill out section 2.2)
 - □ Combination Acquisition & Development/Renovation (fill out both sections 2.1 and 2.2)
- Section 3.0 builds the knowledge to make informed decisions ٠ about impacts to the natural and human environment
- Pre-screening resources are essential to answer questions in Tables 1 and 2
- *Permits = if your work is in an 'aquatic' environment, recommend contacting Army Corps of Engineers and/or Virginia Marine Resource Commission, and floodplain administrators promptly

- Plan for sufficient time! Need to be prescreening project details now
- Many responses take 30 days or more
- Goal is the letters come in prior to application submission
 - This will help applicant and DCR Grants staff
 - At least be sure everything has been submitted to all required agencies by August 28




Figure 1: The NEPA Pathway

- Map be consistent through the review process with project boundary, area of potential effect, current land conditions.
- Project description include depth of disturbance and the scope of LWCF proposed work; include it is for consideration for Federal LWCF Grant Funding

Section 106 – Historical & Cultural Resource Review

Determine Area of Potential Effects - Department of Historic Resources

Closely read the process in the Environmental Review Requirements Document

Multiple steps including the National Park Service must consult with Federally Recognized Tribes

Request for Survey:

If there is a request for a Phase 1 Survey, the review pauses until completed. Costs associated with Survey may be added to the project budget or used as match if approved by NPS

Projects will not be NPS approved without Section 106 resolution.



- Eligible funding for reimbursement must be in original approved budget
- Federal and State procurement procedures must be followed and documented correctly
- Provide quarterly reports
- Drawdowns (reimbursements)
 - Can be intervals for development projects
 - Last reimbursement will come after final inspection and project closeout
 - Acquisition projects drawdown after all property transferred and paid
