### **Photography Permit Conditions**

- 1) Park rules and regulations are enforced at all times.
- 2) Photo sessions may not impede other visitors' normal use and enjoyment of park resources, nor interfere or infringe upon park programs, events or other park-permitted functions.
- 3) Permitted photo vendors are required to contact the Park, (757) 426-7128, at least 48 hours in advance of each visit to be informed of any programs, events, or other permitted functions that may preclude desired session location or time.
- 4) The vendor is required to carry the False Cape issued permit while conducting photography sessions. This must be shown to any ranger who asks to see it.
- 5) The vendor is required to provide proper payment if parking at Back Bay National Wildlife Refuge. The permit DOES NOT exempt the permit holder from Back Bay National Wildlife Refuge's fees. The permit DOES NOT allow for vehicle access in False Cape State Park or through Back Bay National Wildlife Refuge.
- 6) Failure to meet the obligations of permit will result in revocation of the remainder of the permit year without refund.
- 7) The Park reserves the right to refuse any requested session date(s) and location(s) due to conflicts with other Park activities.
- 8) The annual permit fee is \$250 and extends for the calendar year. The annual fee will be prorated based on the month of application. Photographers are responsible for annual renewals.
